This rider is attached to and made part of the agreement between Skyline Music LLC, on behalf of **LEZ ZEPPELIN**. (herein referred to as "Artist") and _____ (herein referred to as "Purchaser") for the performance on _____. Your cooperation in meeting the guidelines found within this agreement is appreciated to help insure the Purchaser, Artist and audience the best possible experience with **LEZ ZEPPELIN**. Should you have any problems in fulfilling the provisions of this rider, please contact the Artist's tour manager. Any revisions you wish to make must be approved by Artist in writing.

Payment

All deposits shall be received by the date specified on the contract. Deposits shall be paid via bank wire (call or email your Skyline Music representative for wire info) or certified check **made out to Skyline Music LLC Artist Deposit Account** and mailed to : Skyline Music LLC, PO Box 38, Jefferson, NH 03583. If you will be mailing a deposit check, please provide your Skyline Music representative with payment and tracking info. Please call if you require a W-9 for a deposit. Payments made on the night of the show **MUST** be made in cash, certified check or a university/school check. **ALL CHECK PAYMENTS MUST BE APPROVED BY ARTIST IN WRITING AND BE MADE OUT TO: IT COULD BE REAL, INC.**

Access

Artists and technicians will have access to the venue 3 (three) hours before doors, and 2 (two) hours after show.

Parking

Well-lit, free parking for (1) van with trailer and one (1) other vehicle must be provided in close proximity to venue, with easy access to the stage entrance, and available for the duration of the evening.

Security

Purchaser will provide adequate security so as to guarantee the safety of the audience and the Artist. Special arrangements will include: a minimum of two security guards situated in front of the stage during the band's performance. **Under no condition will audience members be allowed to access the stage.** Purchaser shall proper security at all times to ensure the privacy and of the Artist, Artist crew and guests, all equipment, and personal property from the beginning of load-in until the completion of load-out. Buyer will be held financially responsible for any loss due to lack of proper security.

Taping

Audio and video recording is allowed, but only with the prior consent of the Artist. Anyone making an audio or video recording at a concert must be willing to sign a release that the Artist will provide. Broadcasting or any such distribution of the audio or video material of any sort, in any medium (including but not limited to television, radio, internet, etc.) may be allowed only with Artist's prior written consent.

Billing

"Lez Zeppelin" shall receive 100% sole exclusive headline billing (or 100% equal co-billing for festivals) in any and all advertising and publicity unless otherwise agreed in writing. with the appropriate headlining billing in any and all printed advertising and must be mentioned in any and all radio. Purchaser shall use only those photographs and publicity materials provided by Artist's representative for advertising and publicizing this engagement. As a special request, we ask that you please forward to SKYLINE MUSIC clippings of reviews, publicity, advertising and copies of original club posters if applicable.

Tickets

A minimum of 24 complimentary tickets will be provided at no cost to the Artist, unless stipulated otherwise by the terms of the Contract.

Radio Station or Product Co-Presents, Promoter Co-Presents

Any proposal for radio station co-presentation of this show including any tie-in with a radio, TV, newspaper or product must be cleared with and approved by Artist prior to any confirmation of such tie-in, co-present or co-promote, if not already approved by Agent prior to this contract's issuance. Also, any co-promote situation with any promoter other than contract signer as shown will first need approval of Agent. There is to be absolutely no corporate or commercial advertising / informational signs or banners directly displayed behind or near the stage area while artist is performing during the entire performance. Nor shall the ARTISTS appearance be sponsored by or in any other way tie-in with any political candidate, commercial product or business. Without written approval by Artist

Meals

Unless stipulated otherwise in the Contract, Purchaser will provide (at no cost to Artist) a healthy, hot, well-balanced meal, consisting of an entree, assorted vegetables, salad and dessert for 6 people at the venue or nearby restaurant. One meal must be a vegan meal and one vegetarian meal. Pizza and Fast food restaurants, i.e. Taco Bell, Burger King, KFC), are not acceptable. Artist’s Tour Manager will designate the meal time, which is generally immediately following sound check. A buy-out of \$15.00 per person (\$90.00) is acceptable.

Dressing Room

A well-lighted, private, lockable dressing room that can comfortably fit 12 persons (**not to be shared with other individuals or acts**) must be provided. If the room cannot be locked, a guard must be posted when the artist is not in the room. Dressing rooms must include chairs, tables, heating/air conditioning, mirrors and a private bathroom entrance. Artist MUST have access to a phone, and if possible an internet connection. The following should be placed in dressing room prior to sound check:

- Six (6) towels (to be returned after the show)
- Twelve (12) large cups for cold drinks
- 1 case (24 bottles @ 12 oz.) of bottled water with half (12) cold and half (12) room temperature
- 1 six (6) pk Diet Pepsi and/or Coke
- 1 six (6) pk V8 Vegetable juice
- 1 six (6) pk Club Soda
- A few small containers of apple and cranberry juice
- 1 case of beer – iced (import or micro-brew ONLY)
- 1 bottle of Johnnie Walker Black Scotch
- 1 bowl of fresh uncut fruit in season (bananas, grapes, apples, and pears ONLY).
- Cheese and crackers
- 1 plate of Crudite (Cut raw vegetables) and 1 container hummus
- 1 package of fat free Fig Newtons
- Chips and Medium Salsa and/or 1 bag Original Chex Mix
- Trail mix with nuts and raisins
- Coffee pot with fresh, not powdered, cream and sugar
- One pot of hot water with assorted caffeinated and de-caffeinated teas, including herbal teas.
- Two dozen hot container disposable coffee cups, spoons, napkins.

Lodging

Unless stipulated otherwise in the Contract, Buyer will provide five (5) QUALITY double rooms (away from elevators, ice/vending machines, or the hotel’s main central air conditioning/ventilation unit) at a nearby (10 miles max) established, nationally franchised, hotel for the evening of performance, and provide Artist’s tour manager with a confirmation number in advance or upon load-in. Buyer must provide a 1pm check out. Hotels should include free high speed internet, health club and restaurant. Suggested hotels: Radisson, Ramada, Holiday Inn and Hilton. **Be sure to guarantee the rooms for late arrival and late checkout. Please contact management no less than three weeks before the gig with the hotel information.**

Cancellation

If Purchaser cancels the performance less than four weeks before the performance, Purchaser will pay Artist 50% of the guaranteed fee for the performance. If Purchaser cancels the performance less than two weeks before the performance, Purchaser will pay Artist 100% of the guaranteed fee for the performance. The parties agree that such payments are reasonable in light of anticipated or actual harm caused by the cancellation and the difficulties of proving the actual damages to Artist.

General

Nothing contained in this Agreement or the accompanying Rider constitutes either Purchaser or Artist a partner or employee of the other party. This Agreement and the accompanying Rider(s) express the complete understanding of the parties and may not be amended except in a writing signed by both parties. If a court finds any provision of this Agreement or the accompanying rider invalid or unenforceable, the remainder of this Agreement will be interpreted to best carry out the intent of the parties.

In the event of any dispute arising from or related to this Agreement, the prevailing party is entitled to reasonable attorney's fees
